The Executive Committee of the British-Romanian Association announce, with great sorrow, the passing away, on 9th September, of Ecaterina Iliescu.

Our beloved Titinica was one of the most remarkable and formidable human beings that existed and a shining example to us all.

Born in Romania, in one of the most distinguished and cultured families of our country, Titinica's exceptional gifts became obvious quite early. She finished her education with three degrees: one in Economic Sciences, from the Commercial Academy in Bucharest, one in Music, from the Bucharest Conservatoire and one in Law from the University of Bucharest, followed by a doctorate in Law from Sorbonne University in Paris. Subsequently, she embarked on a legal career, as a recognised authority in International (and Romanian) Law, with the piano as her "violon d'Ingres".

She soon married George-Emil Iliescu, aide-de-camp to the King in the late 1920's, and, in the 1930's, they arrived at the Romanian Embassy in London, where he became military attaché and Titinica legal councillor.

Unhappy with Romania joining the war effort on what they perceived to be the wrong side, the Iliescu couple, Ambassador Viorel Ilies, as well as other members of the Embassy staff, decided to seek refuge and remain in England at the outbreak of hostilities: thus they have had the sad distinction of being, at least so far, the last genuine diplomatic representatives of a free Romania accredited to London.

During the war, Titinica and her husband wrote and broadcast extensively, trying to explain, to a free world reluctant to understand and accept, that the first phase of the armed effort - directed to the liberation of Bessarabia, annexed by the Soviet Union following the Ribbentrop-Molotov pact - was justified; they took strong exception to Romania's involvement in the war beyond this point.

After the war, Titinica became a legal consultant to the United Nations. However, she threw herself more and more, with
